

CEMETERY REGULATIONS FOR THE TOWN OF BOSCAWEN, NEW HAMPSHIRE

Approved and effective January 2, 2018 by the Cemetery Trustees

1. The Cemetery Trustees shall be responsible for all cemetery affairs and shall compile and have printed the Rules and Regulations, making them available to the public, revising them as conditions change.
2. All lot owners shall be governed by Rules and Regulations established by Cemetery Trustees.
3. All Town cemeteries shall be kept in such conditions as to be a credit to the community. This entails a minimum of annual mowing.
4. All lots shall be sold to include perpetual care and corner markers. Price as of January 2, 2018 is \$475 with \$200 for Perpetual Care, \$175 for Corner Markers and \$100 for the Town. "Perpetual Care" shall mean general maintenance of the cemetery grounds.
5. A concrete vault or liner is required for all burials, including a suitable container for cremation. Lots shall be for human remains only.
6. The purchase and maintenance of monuments or stones shall be lot owner's responsibility.
7. No monument or stone shall be erected until the lot purchase is paid in full. Within one year of purchase, four corner markers with the person's initial shall be placed on the lot by the Town.
8. Only one upright monument per deeded lot is allowed. Single grave markers and corner markers shall be flush with the grade.
9. No fencing, curbing, or enclosure of any kind shall be allowed around any lot. Any shrubs should not be allowed to "overpower" the stone and/or marker, to be taller than the stone, or to grow in front of the stone so as to make the stone unreadable. The Town reserves the right to remove trees or shrubs that infringe on neighboring lot, become hazardous or hinder cemetery maintenance. As of January 1, 2005, no perennial flowering plants or shrubs shall be planted.
10. No lot owner shall erect or place or cause to be placed any monument without prior approval of location by the Public Works Director or the Cemetery Trustees.
11. No change or grade or any other work will be done without the approval of the Public Works Director or the Cemetery Trustees.
12. No snowmobiles, off-highway recreational vehicles, horses or other animals shall be permitted in the cemetery.
13. Lots shall be available subject to decision of the Public Works Director or Cemetery Trustees.
14. **Interments:**
Graves will not be opened between December 1 and March 31 unless conditions demand otherwise.
All burials will require 48 hour notice and be under direction of the Public Works Director.
15. In case of hardship, special consideration may be granted.
16. The owner of a lot may sell the lot back to the Town for price originally paid if adequate proof is presented. Cemetery lots are not investments. Payment for corner markers will not be refunded.
17. The purchase of one plot will allow the interment of:
1 casket or
1 casket and 1 cremation or
3 cremations
18. The Town shall have authority to remove all floral designs, flowers, weeds, trees, shrubs, plants or herbage of any kind, from the cemetery, as soon as, in the judgment of the Public Works Director or Cemetery Trustees, they become unsightly, dangerous, detrimental, or diseased, or when they do not conform to the standards maintained by the Town. The Town shall not be liable for floral pieces, baskets, or frames in which or to which such floral pieces are attached. They shall not be liable for lost, misplaced, or broken flower vases. The Town shall not be responsible for frozen plants or herbage of any kind, or for plantings damaged by elements, thieves, vandals, or by other causes beyond its control.
19. The lot owner shall sign one copy and return it to the Town Office.
