At a regularly scheduled and duly noticed meeting of the Boscawen Planning Board on Tuesday, July 6, 2021 at 6:30pm, the Board *approved* the following: Application for Conditional Use Permit & Minor Site Plan Review for Earth Excavation, submitted and owned by Ryan Stacy LLC, 11 Vaughn Road, Bow NH 03304 with a location of Map 47 Lot 6, 243 Daniel Webster Highway, located in an R1 zone, with the following conditions:

- 1. Applicant must come back to the Planning Board if they are to start blasting;

- 4. Work with Association of Bosniaks to find out times of services.

<u>Regulations</u>: The Ryan Stacy LLC earth excavation operation at 243 Daniel Webster Hwy in Boscawen is governed by the following local, state and federal regulations:

- Boscawen Planning Board Notice of Decision dated July 7, 2021, attached.
- New Hampshire RSA 155: E Local Excavations Regulation.
- US Department of Labor Mine Safety & Health Administration Regulations.

<u>Conditions:</u> The Ryan Stacy LLC earth excavation operation at 243 Daniel Webster Hwy in Boscawen is subject to the following conditions:

- Hours of Operation for Ryan Stacy LLC earth excavation operation shall be Monday through Friday, 7:00 AM to 5:00 PM and Saturday 7:00 AM to Noon. There is to be no activity before or after stated hours, on Sunday or the following Holidays: New Year's Day, Martin Luther King Day, Presidents' Day, Memorial Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, and Christmas Day.
- The Bond or Cash Escrow in place for Tax Map 47, Lot 6 as determined by Boscawen's Town Engineer shall remain in full force until reclamation is complete and is released by the Boscawen Planning Board.
- Ryan Stacy LLC shall go back to the Planning Board, prior to blasting.
- This operation shall be reviewed by the Town Engineer, yearly, starting no later than one year from the date of issue.
- Ryan Stacy LLC shall work with the Association of Bosniaks to determine times of services at the cemetery for coordination.
- This permit shall expire five years from the date of issue.
